# **3 THINGS YOU CAN DO TO PROTECT YOURSELF FROM EVICTION:**

- Let your landlord know NOW in an email, text, or written letter that you will be unable to pay rent due to income loss. Save a copy for your records.
- 2. KEEP any proof of loss of income and SEND photos of these documents to your landlord.
