A. Report on Closed Session by City Attorney

Assistant City Attorney Heidi Quinn reported Council received a status as on negotiations with the General Employees Association, that Council provided general direction, but announced no specific reportable action was taken.

- A. Second Reading of an Amendment to the City's Claims Ordinance
Action: Held a second reading and adopted Ordinance 16-014 to amend Pacific Grove Municipal Code (PGMC) Chapter 6.06, Section 6.06.055 to increase the City Manager's authority to act on claims against the City from under \$15,000 to under \$35,000 and to allow the City Manager authority to reject claims in any amount that are deemed not to be a proper charge against the City, and to modify Council Policy No. 000-7 accordingly.
- B. Second Reading of an Ordinance Amending the Fiscal Year 2016-17 Budget and Establishing a Special Revenue Fund and Budget for the Coastal Conservancy Grant
Action: Held second reading and adopted Ordinance 16-015 amending the Fiscal Year 2016-17 Budget and establishing a special revenue fund and budget for the Coastal Conservancy Grant.

- B. First Reading of an Ordinance to Amend the City Salary Classification Schedule

Action: Upon motion by Councilmember Lucius, the Council voted 7-0, to introduce and hold first reading of an ordinance to amend the salary classification schedule, to (1) Modify salary range for Police Sergeant, Police Corporal, Police Officer, Police Reserve Officer I, Police Reserve Officer II, and Police Reserve Officer III; (2) approve the amendment; and (3) direct that a summary of a proposed ordinance be published as approved by the City Attorney.

Action: Upon motion by Councilmember Fischer, the Council voted 6-1, Councilmember Peake dissenting, to hold second reading and adopt Ordinance 16-016 Amending the Fiscal Year 2016-17 Budget to:
 - 1. Reallocate 1 Full Time Equivalent (FTE) Engineering Technician to 1 FTE Program Manager.

2. Increase .5 FTE Administrative Technician to 1 FTE
3. Establish 4 FTE Positions on Loan


