# PARTS- South County addresses synthetic drugs (K2/Spice (Synthetic Marijuana) and Bath Salts)

PARTS is concerned about the prevalence and dangers associated with the sales, death, intoxication, and public safety concerns of synthetic based drugs throughout Monterey County. These drugs are also known as Designer Drugs. Several Police Chiefs in South County, including the Chiefs of King City, Greenfield, Soledad and Gonzales shared testimonies and statistics in a recent South County Joint Council meeting.

## Background:

**K2/Spice (also known as synthetic marijuana)** consists of plant material that has been sprayed with chemicals that mimic THC, the active ingredient in marijuana that gives a euphoric effect. Synthetic marijuana binds to the same receptors in the brain as marijuana. While marijuana is generally not deadly, its synthetic version is not regulated by the federal government and its chemical composition is known only to the street chemists. Common effects of ingesting K2/Spice are: hallucinations, anxiety, paranoia, and giddiness. The physiological effects of K2 are increased heart rate, elevated body temperature, and increased blood pressure. Some of the other effects are increased agitation, seizures, uncontrolled spastic body movement, and even death. K2/Spice first became available in the United States in 2008. It is often marketed as incense, and labeled “not for human consumption” which allows it to be imported and distributed in great quantities.

While there has been much legislation enacted to combat the ever increasing popularity of designer drugs, as soon as chemicals are identified and outlawed, other synthetic chemicals are developed to replace them, making legislation inert.

## **Bath Salts**

These designer drugs are called bath salts because they are generally sold in crystal form that look like every day bath salts. Unfortunately these drugs are so unpredictable, that even a single use can cause death. Bath Salts are cathinones, an amphetamine product that has horrible side effects. Bath Salts are known to create an “excited delirium” with body temperatures of 105F or higher.

According to Monterey County Juvenile Probation System, synthetic drugs like K2/Spice or bath salts are the drug of choice in youthful offenders. The Office of National Drug Control Policy also notes that nationwide, the use of synthetic cannabinoids is alarmingly high, especially among young people. According to the 2012 Monitoring the Future survey of youth drug-use trends, one in nine 12th graders in America reported using synthetic cannabinoids in the past year. This rate, unchanged from 2011, puts synthetic cannabinoids as the second most frequently used illegal drug among high school seniors after marijuana.

Because of the extreme danger that these synthetic drugs cause due to their unknown chemical components, potency and wide availability, PARTS supports banning the sale, possession and distribution of all synthetic drugs throughout Monterey County and congratulates the cities of Soledad, Gonzales, and Greenfield for adopting city ordinances to that effect. One of the primary goals of Sun Street Centers is to improve the health and safety of our neighborhoods through environmental and policy changes.

## PARTS Salinas Addresses Alcohol Licenses in Salinas

PARTS is concerned about the proliferation of Type 20 and 21 Off Sale beer and wine licenses in neighborhoods that already have sufficient outlets. PARTS worked hard to preserve the "one for one" license policy that worked so well in Salinas for a number of years.

Unfortunately, the community lost that debate on July 9, 2013 when the City Council formally abolished the "one for one" policy.

Quick Background: Alcohol Beverage Control (ABC) of the State of CA determines the number of approved Type 20 and 21 alcohol licenses in the City of Salinas. PARTS focuses on the sales of Type 20 and 21 Off-Sale licenses that together allow the sale of beer, wine, and spirits in unopened, original containers. These 2 types of licenses only apply to liquor and grocery stores, gas stations, etc. Type 20 and 21 licenses do not apply to restaurants, bars, and wine tasting rooms, clubs and establishments considered On-Sale.

Some business investors requested the Salinas City Council to eliminate the "one for one" Liquor Licensing policy. That meant to get a license one had to become available, leading to the description of "one for one". After July 9, 2013, a business owner could request a Type 20 or 21 license and after review by the City, if the business met the requirements of the City, a new license would be granted.

According to an ABC data report on August 6, 2015 the City of Salinas had 68 Type 20 and 23 Type 21 alcohol licenses currently active. PARTS strongly believes regulating the number of Off-Sale alcohol outlets in a given census tract has been proven to be the best tool to avoid underage drinking. Here are the factors to consider:

1. Clustering outlets in a small geographic neighborhood;
2. Outlets near parks, schools, or churches, or where young people meet;
3. Neighborhoods with a dense population base;
4. Criminal statistics in the neighborhood.

Here is a very recent quote from the Pacific Institute for Research and Evaluation... "A number of studies have found that in and near neighborhoods where there is a high density of places that sell alcohol, there is a higher rate of violence." (June 2015)

In light of the above factors, PARTS will continue to oppose Type 20 and Type 21 alcohol licenses being issued where location adds to the risk of underage drinking. The once "one for one" alcohol outlet policy helped eliminate the overconcentration of outlets in City of Salinas. One of the primary goals of PARTS is the health and safety of our communities while improving our neighborhoods, through environmental and policy changes.

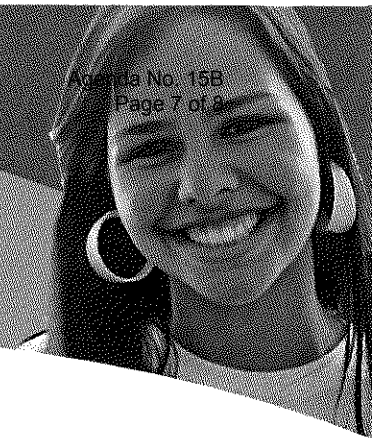

D.A.I.S.Y., or Drug and Alcohol Intervention Services for Youth, provides intervention and education services for substance abusing youth ages 13-18 who are referred by parents, schools, Social Services, Behavioral Health, Probation and Juvenile Drug Court. Through individual and group counseling, the program works to raise consciousness, inspire hope, and motivate informed, internally driven, sincere decisions to change.

## services

D.A.I.S.Y. utilizes the Seven Challenges curriculum, an evidence-based best practice. The program is designed specifically for adolescents with drug problems, to motivate a decision and commitment to change and to support success in making the desired changes. Seven Challenges provides a framework for helping youth think through their own decisions about their lives and their use of alcohol and other drugs.

DA.I.S.Y. also offers a Parent Support Group to help parents better understand and support their children and to provide them with the information and tools to help their children in recovery. Themes covered in the group include building confidence, school absenteeism, identifying and preventing gang involvement, family dynamics, and school graduation requirements.

D.A.I.S.Y., o servicios de intervención para jóvenes quienes usan drogas y alcohol, provee servicios de educación y tratamiento para jóvenes de 13-18 años de edad. Los participantes son referidos por sus padres, escuelas, servicios sociales, el departamento de salud mental, la corte o el departamento de libertad condicional juvenil. A través de consejería grupal e individual, el programa crea conciencia, inspira esperanza y motiva las decisiones sinceras de cambio.

## Servicios

El Programa DAISY utiliza el currículo de Los Siete Retos, un programa basado en la investigación científica y con resultados comprobados. El programa está diseñado específicamente para adolescentes con problemas de drogas, para motivar la decisión y el compromiso al cambio y apoyar el éxito en hacer los cambios deseados. El programa de los siete retos provee un marco de ayuda en el que los participantes reflexionen en sus propias decisiones acerca de su vida y el uso de las drogas y el alcohol.

D.A.I.S.Y. también ofrece un Grupo de Apoyo de Padre. El grupo de apoyo tiene como objetivo crear conciencia en temas que les ayuden a entender mejor y a apoyar a sus hijos. Los participantes se les proveerán con las herramientas necesarias para asistir a sus hijos en su recuperación. El temario de los padres es como sigue pero no se limita solo a esos temas: Construyendo la confianza, el absentismo escolar: su definición, proceso legal y consecuencias; las pandillas: signos tempranos y lo que los padres pueden hacer para prevenir que su hijos se asocien con pandillas; dinámicas familiares y los requisitos de graduación de preparatoria.

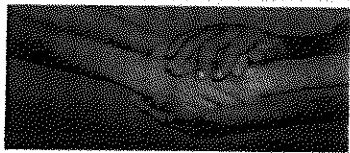
