## RECOMMENDATION

Approve a resolution declaring 2016 the Year of the Veteran in Pacific Grove.

### DISCUSSION

On February 9, 2016, the Monterey County Board of Supervisors passed a Resolution declaring 2016 to be the Year of the Veteran in Monterey County. In 2016, the California Central Coast Veterans Cemetery in Seaside will open, as will the Department of Defense Joint Health Center in Marina. In 2016, the Veterans Transition Center will conduct a ground breaking to expand its facilities, and the Monterey County Veterans Court will become operational. Marina and Seaside have passed similar resolutions acknowledging the year of the veteran. Carmel and Monterey are considering such resolutions as well.

Given that we have 35,000 veterans living on the Central Coast, proclaiming 2016 to be the Year of the Veteran in Monterey County and in our own city is a great way to show our respect and gratitude for the service of all veterans to our community and to our country.
