### RECOMMENDATION

Release funds remaining in the City's account to the Monterey Homeless Challenge fund.

#### DISCUSSION

The cities of Monterey, Pacific Grove and Carmel recently dedicated \$1 per resident to the Monterey Homeless Challenge to provide services to our homeless neighbors and residents. This effort has raised a total of \$47,423 which is now available for disbursement.

The City of Monterey invited organizations to submit an application requesting funding for homeless services to be provided in winter 2016 for individuals located or served on the Monterey Peninsula.

These applications were sent to Community Homeless Solutions, Community Human Services/Safe Place, Fund for Homeless Women, The Gathering Place, I-Help, Interim/McHome, Pass the Word Ministry/One Starfish, Salvation Army, Veteran's Transition Center and the Coalition of Homeless Services Providers.

Applications were due, via email, to the City of Monterey's Community Services Director, Kim Bui-Burton, at <u>buiburto@monterey.org</u>, by this past Friday, September 16, 2016 at 5 pm. The City of Monterey staff now anticipates a quick internal review and turnaround; with staff recommendations to a committee of City representatives by early October, and disbursement by the end of October or early November.

From our original Pacific Grove Homeless Challeng Grant fund raising effort, we still have \$8,012 left over. Originally, the idea was to keep this in a reserve fund for emergencies that

might arise. No such emergencies have arisen, and the addition of these funds would bring the total for the current effort to \$55,435.

It is therefore recommended that the City release the remaining funds to the Monterey Homeless Challenge fund.

#### FISCAL IMPACT

The Homeless Challenge monies were deposited in Housing Fund 15 in Fiscal Year 2015-16. Pursuant to the table below, the \$8,012 balance of the Homeless Challenge dollars would be distributed to the City of Monterey for use in this year's program.
