

**RESOLUTION NO. 15-014**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE AMENDING THE PACIFIC GROVE MUNICIPAL MASTER FEE SCHEDULE TO SET BAIL FOR OVERTIME PARKING VIOLATIONS**

**FINDINGS**

1. Pacific Grove Municipal Code Chapter 6.02 provides fees be set to recover costs reasonably borne by the City to provide any regulation, product, or service.
2. Pacific Grove Municipal Code Chapter 16.40 prohibits or limits stopping, standing, or parking of a vehicle in a variety of provisions and times, including 16.40.530 which limits parking (with authorized signage), to no longer than three hours at any time between the hours of 9:00 a.m. and 6:00 p.m. on any day except Sunday and holidays.
3. There is no current set bail for three hour overtime parking violations.
4. The proposed bail amount is consistent with the other overtime parking violations.
5. Public Notice of the proposed fee was published in the Monterey County Herald on February \_\_\_, 2014.
6. The City Council conducted a public hearing regarding the proposed bail on February 18, 2015.
7. The resolution does not constitute a “Project” as defined by the California Environmental Quality Act (CEQA).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE:**

1. The foregoing Findings set forth above, and by this reference incorporates each as an integral part of this Resolution.
2. The City of Pacific Grove FY2014/15 Master Fee Schedule shall be amended to set fees for parking bail, as follows:
