

Rebuttal to Argument Against Measure P

Contrary to what those against Measure P would like you to believe this is not aimed at non-profits. In fact, what they fail to mention is that the tax is on "admissions" and is paid for by the people, mostly from out of town, who are using our streets, parks, trails and general services while not paying a penny in for their upkeep.

As was pointed out in the argument in favor of the tax, each property owner in Pacific Grove would have to pay \$500 A YEAR in order to equal the 5% admission tax.

California Elections Code – Ballot Arguments, Form of Statement to be filed

§99164, 9283, 9501.5 A ballot argument shall not be accepted unless accompanied by the printed name and signature or printed names and signatures of the person or persons submitting it, or, if submitted on behalf of an organization, the name of the organization and the printed name and signature of at least one of its principal officers.

No more than five signatures shall appear with any argument submitted under this article. In case any argument is signed by more than five persons, the signatures of the first five shall be printed.
