a. Use Permit (UP) 16-093

Address: 77 Asilomar Ave (Pacific Grove Golf Links)

<u>Description:</u> To install protective barrier netting (35 feet height x 320 feet length) including 7 poles, and to plant 6 trees, along the fifth hole of Pacific Grove Golf Links

On a motion by Commissioner Byrne, seconded by Commissioner Chakwin, the Commission voted 4-2-1 (Commissioner Aeschliman and Murphy oppose, and Chair Fredrickson absent) to recommend City Council approval of the ordinance, complete with staff and CEQA findings, and the following conditions: to allow only one unit of a duplex to be licensed, to keep Home Sharing as a separate ordinance, to prohibit gatherings and parties, to eliminate "business license" required, and to change the date for Asilomar dunes properties requiring use permits starting March 31, 2018. Motion passed.
