Kurt Overmeyer, Economic Development Manager, presented the report, including a revision to Section 7.1.2 of the development agreement.

Action: Upon motion by Councilmember Fischer, and carried on a 6-0 vote, the City Council authorized the City Manager to execute the Development Agreement, as amended, and a License Agreement with SiFi Networks to build a fiber-to-the-curb network throughout Pacific Grove.

B. Council and Community Support for Chief Myers and the Police Department Thomas Frutchey, City Manager, presented the report and noted that Reserve Officer Gorman was unavailable but wanted to express that the department is heading in the right direction. Audience members in support included Richard Stillwell, resident; Mike Becker, Chamber of Commerce; Matthew Meyers, law enforcement professional. Barbara Martinez spoke in support during general public comments. Hazel Tompkins feels the Chief should pick either Seaside or Pacific Grove. Interim Police Commander Cassie McSorley introduced Pacific Grove public safety members in the audience.

Action: Upon motion by Councilmember Fischer, and carried on a 5-0-1 vote, Councilmember Miller abstaining, the City Council adopted Resolution 14-020 summarizing Council and community support for Chief Myers and the Police Department
