CALL TO ORDER

Mayor Kampe called the meeting to order at 6:00 p.m. Present: Mayor Kampe, Mayor Pro Tem Huitt, Councilmembers Cuneo, Fischer, Lucius, Miller, and Peake.

Councilmember Huitt led the pledge of allegiance.

City Manager Frutchey requested Full Presentations item 14.A. become Presentations item 2.B. Action: Upon motion of Councilmember Cuneo and carried on a 7-0 vote, Council approved the Agenda, as amended.

- A. Mayor Kampe read and presented a proclamation to Barbara Mossberg, Poet in Residence. Ms. Mossberg thanked the Council and public for their support, and shared some personal poems.

 Mr. William Merry presented the Council with an overview of the District, its upcoming programs, and the need for capital improvements. He answered Council's related questions.

A. Report on Closed Session by City Attorney

Mr. Laredo reported that Council met for the special closed session meeting on the items noticed. He reported due to a shortage of time, item B. was not discussed but Council would reconvene after the regular meeting to discuss. As to item A., Mr. Laredo reported that the City is in active negotiations for successor agreements with Labor Organizations, that Council was provided status as to the meetings that had occurred and of the planned December and January meetings, that Council received both positions of the City and Labor Organizations, and that staff received general direction from the Council. No reportable action was taken.

Councilmember Huitt reported that the small gift of M&Ms received by Council was gifted by an anonymous donor in the spirit of the "lady in black," Meg Manus. Ms. Manus, in her time, was known to offer small gifts and positive feedback to Council. Councilmember Cuneo noted he, along with Councilmembers Fischer and Peake, were able to attend the police department's Swearing in Ceremony that took place earlier in the day for Commander Lakind and Administrative Services Manager Francis. Councilmember Fischer expressed a positive experience at the PG Golf Links and encouraged all to play there and also encouraged local shopping. Councilmember Lucius acknowledged receipt of a letter from the Beautification and Natural Resources Commission and thanked the Commission for their work on the tree ordinance. Mr. Frutchey reminded all of the food barrels at the Library and City Hall, the closure of City Hall, and the reduced schedules of the Library and Public Works departments.
