#### 11. PUBLIC HEARINGS

A. Appeal of Planning Commission's approval of Use Permit #17-1111 to allow a new pole with a small-cell antenna and associated wireless telecommunications facility equipment, including a meter pedestal, along the public right-of-way. Public comment for this item was received during the General Public Comment Section 4.

Action: Upon motion by Councilmember Huitt and seconded by Councilmember Cuneo, the Council voted 6-0-1, Councilmember Smith absent, to postpone the public hearing for the appeal until the regularly scheduled City Council meeting of Wednesday, September 5th, 2018 at 6:00 p.m.

B. First reading of an Ordinance to amend the Truck Routes listed in the Pacific Grove Municipal Code

No public comment was received.

Action: Upon motion by Councilmember Cuneo and seconded by Councilmember Fischer, the Council voted 6-0-1, Councilmember Smith absent, to introduce and hold a first reading of an Ordinance amending the Truck Routes listed in Pacific Grove Municipal Code Section 16.56.100, to conform to the routes as posted throughout the City of Pacific Grove (City) and connecting to the designated truck routes in the City of Monterey and direct that a summary of a proposed ordinance be published as approved by the City Attorney.

CEQA: Class I Exemption under the California Environmental Quality Act (CEQA) Guidelines Section 15301, Existing Facilities

C. Continuation of Public Hearing on Call Up of Architectural Permit and Use Permit Application No. AP/UP 16-203 to allow the demolition of the existing single-story building and to build a revised 116- room, four-story hotel. The project proposes a total gross floor area of 76,182 square feet on a 0.77 acre lot pursuant to PGMC §23.31.020

Councilmember Fischer declared an ex parte discussion/meeting with Mr. Laith Agha.

CEDD Director Mark Brodeur presented staff report.

Mayor Kampe explained protocol sequence.

City Attorney David Laredo reminded Council and the public that this is a continued hearing comment should be limited to the new information present tonight.

Applicant/Architect/Owner Victor Montgomery, Randy Russom, and Laith Agha were present. Mr. Montgomery and Mr. Russom were provided fifteen (15) minutes for presentation.

Mayor Kampe opened the Public Hearing.

Public comment for three (3) minutes each was received from Tom McMahon, Clarissa Rowe, Moe Ammar, Jane Haines, Lisa Ciani, Howard Mathews, Janet Cohen and Glenn Gurries. Public Comment for two (2) minutes each was received from Richard Stillwell, Dave Dixon, Antony Tersol, Vicky Vakee, and Jeff Becom.

Mr. Mongomery offered no rebuttal, but remained available for questions.

Mayor Kampe closed the Public Hearing.

Council dialogue began.

Action: Upon motion by Councilmember Huitt and seconded by Councilmember Fischer, the Council voted 5-1-1 (Councilmember Peake dissenting, Councilmember Smith absent) to approve the resolution as presented via Revised Errata, with modifications to Fact 6., modifications to Conditions 5. and 12., deletion of Conditions 5. and 20., addition of two new conditions regarding bulbouts and trip reduction measures; the revise Resolution is to return to Council on September 5, 2018, for ratification of the revised and added conditions, only. *CEQA: Environmental Impact Report*
