# 3. Approval of Minutes

#### 7. Regular Agenda

a. Hopkins Marine Station History and Role in Shoreline Research and Protection

**Reference:** Dr. Stephen Palumbi, Director, Hopkins Marine Station, Stanford University

#### **Recommended Action:** Receive as information

Dr. Palumbi gave on overview of the Hopkins Marine Station, the institution's mission and role in the community. He clarified that Hopkins monitors wave levels in Monterey Bay, but not sea level rise. He also stated that over the last century sea level has risen approximately 8" and that wave energies appear not to be increasing, but more storms are expected. Storm wave height and resultant damage caused may become more of an issue.

#### b. Local Coastal Program Update – Draft Land Use Plan Review

**Project Description:** Continue the review and comment period for the Local Coastal Program Draft Land Use Plan.

The Vice-Chair opened the meeting and the following public comments were received:

- -Marion Morelli of the Monarch Pines mobile home park reiterated points in her July 13, 2015 letter;
- Dr. Palumbi spoke of the Hopkins fence and protection of the seals. He also spoke of the ice plant cover and how it prevents erosion and sediment filled runoff from entering the bay;
- -Inge Lorentzen Daumer stated the current Hopkins fencing works well;
- -Jane Haines reiterated points in her June 29, 2015 letter;
- -Judy Cole of Monarch Pines reiterated points in her July 13, 2015 letter;
- -Bruce Obbink spoke of reducing trail and golf course conflicts;
- -Tony Ciani recapped points in his July 16, 2015 letter;
- -Lisa Ciani recapped points in her July 14, 2015 letter;
- -John Pearce spoke of Pacific Grove's unique sense of place and to capture that more effectively in the Plan.

The public comment period was then closed.

The Planning Commission discussed the May 2015 Draft Land Use Plan starting at Section 3.4.10 and completed review of the document.

After a detailed discussion of the remainder of the document, the Planning Commssion discussed public participation, including a possible workshop, and timeline of the Coastal Commission grant and deliverables. The grant currently expires on April 30, 2016.

On a motion by Chakwin, seconded by Byrne, the Commission voted 5-0-2 to

request an extension of the grant and hold at least one workshop meeting on the Draft Land Use Plan. The motion carried.

On a motion by Commissioner Aeschliman, seconded by Commissioner Chakwin, the Commission voted 5-0-2 to accept the minutes. Motion carried.
