**Permit Application:** Architectural Permit (AP) 16-212

**Description:** To allow the demolition of the existing residence and to build a new 2,186 sf one story residence with a 722 sf detached garage for a total of a 2,908 sf single- story residence.

(Edmonds opposed) to approve Architectural Permit (AP) 16-212, with the following conditions:

- a) Document the existing house through plans, photographs, etc;
- b) Adopt the "Dark Sky" concept for low and down lighting;
- c) Install a 6 ft. fence surrounding property (both neighbors to agree on the fence type);

# 10. Reports of Council Liaison, Rudy Fischer

Councilmember Fischer informed the Board that the Mayor proclaimed May as the Building Safety month and that the Council enacted the Safe Sleeping program. Councilmember Fischer updated the Board that City Council denied the appeal of UUP No. 15-671 and upheld the Planning Commission's decision. Councilmember Fischer also informed about the continued conditional appeal on the golf course netting project.
