a. Call-Up of Architectural Review Board decision

Address: 400 Grove Acre Avenue

Permit Application: Architectural Permit #17-347

Project Description: Call-Up of Architectural Review Board's approval to allow a second-story addition of 905 square feet, to an existing single-story residence of 1,594 square feet, to

create a total of a 2,499 square feet two-story single-family residence. The project also proposes a partial vegetated roof of 486 square feet.

Applicant/Owner: Casey & Allison Lyon, property owners **Zone District/ Land Use:** R-1-B-3/Low Density to 5.4 DU/ac

Assessor's Parcel Number (APN): 006-421-024

CEQA Status: Categorical Exemption, Section 15301(e)(1), Class 1

On a motion by Commissioner Byrne, seconded by Commissioner Lilley, the Planning Commission voted 7-0 to uphold the ARB's approval, with the following conditions: (1) the roof shall not be used or improved to be used as a deck; and (2) the exterior walls may include either cement plaster or stucco, but not both; and (3) that a survey to verify that the building height does not exceed the maximum height of 25 feet shall be performed by a qualified surveyor, and submitted to the City of Pacific Grove. Motion passed.
