NOTICE INVITING SEALED BIDS FOR **RECREATION TRAIL ACCESSIBILITY IMPROVEMENTS** **RE-BID (2)**

The City of Pacific Grove invites sealed bids for construction of street and parking lot improvements and enhancements of Lovers Point Park. This is a second re-bid for the previous project re-bid on January 11, 2019.

The size of the project is approximately 4.4 acres. The work shall be completed in one phase as described below:

- There are renovations to the existing parking lot which include the construction of new curbs, gutters, and entry apron; construction of new ADA stalls with raised planter curb; an addition of a walkway leading from the ADA stalls to the sidewalk; and new planting areas. The terminus of the Recreation Trail will also receive an improved transition, including reinstalling existing pavers to meet new grades. New sidewalks adjacent to the driveway entry will be constructed which include adjustments of utilities. Plant bed areas are limited to fine grading, planting soil, a mulch layer, and irrigation stub outs; no plants included.
- There will be the integration of various parallel parking spaces along Ocean View Blvd. including new curb and gutter.
- The existing diagonal parking spaces located at the terminus of Forest Ave. will be demolished and replaced with a new park and plaza area. Constructed features include pervious paving with metal edging, an accessible ramp, concrete seat walls and retaining walls, truncated dome installation, decomposed granite areas, plant bed areas, irrigation point of connection assembly; and irrigation valve and stub outs to the plant bed areas. Planting bed areas are limited to fine grading, planting soil, a mulch layer, and irrigation stub outs; no plants included.
- The crosswalk at Oceanview and Forest Avenue, connecting to the new park and plaza area, will be regraded with a new AC overlay. Additional improvements include adding flush curbs at corners and adjustments to associated street utilities. Street stormwater drains are added.
- Also including other Work indicated in the Contract Documents.

All bids submitted shall meet the following terms and conditions:

1. Bids shall be delivered to the office of the City Clerk at City Hall at 300 Forest Avenue, not later than the hour of 2:00 p.m., on Friday, November 15, 2019, at which hour and date all bids will be publicly opened and examined. Bids shall be submitted in a sealed envelope, and the outside of the envelope shall be clearly marked, "RECREATION TRAIL ACCESSIBILITY IMPROVEMENTS RE-BID (2)". It is sole responsibility of the bidder to see that his bid is received in proper time. Any bids received after the scheduled closing time for receipt of bids may be rejected.

2. Any bidder may withdraw his or her bid, either personally or by email or written request at any time prior to the scheduled closing time for receipt of bids, but no bidder may withdraw his or her bid for a period of sixty (60) days after the opening thereof.
3. All bids submitted shall include a completed "Proposal", which is included in the Bidder Package. Each bid must be accompanied by Cash, Cashiers' Check, Certified Check or Bidder's Bond in an amount equal to not less than 10% (ten percent) of the total amount of the bid price. The work performed under this contract must conform to requirements of the project Technical Specifications and Special Provisions, which are described in the Bidder Package.
4. The contract will be awarded to the lowest responsible bidder (as defined in the City purchasing regulations) whose work, in the opinion of the Council, will best meet the requirements of the City of Pacific Grove. It is clearly understood by all bidders that said Council reserves the right to reject any and all bids and to waive informalities in said bids.
5. A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5.
6. In accordance with the provisions of California Labor Code Sections 1770, 1773, 1773.1, 1773.2, 1773.6, and 1773.7, the current prevailing wages in Monterey County, California, as determined by the Director of the California Department of Industrial Relations as required to be paid to mechanics and laborers, employed directly upon the site of the work.
7. Time is of the essence for this project and bidders should review the project time frame contained in the "Special Provisions" to insure they can meet the project guidelines concerning scheduling of work and special actions required in the course of work.
8. A Bidder Package, including plans and specifications, special provisions, sample contract, and proposal forms may be seen and obtained at office of Neill Engineers Corp., SW corner of Mission and Fifth, P. O. Box LL, Carmel, CA 93921, (831) 624-2110. A non-refundable fee of \$100 made payable to the City of Pacific Grove will be required for each full size set of plans and specifications including a CD. A non-refundable fee of \$25 will be charged for a CD only. Additional charges will be imposed for mailings of plans, specifications and/or CD. Plans, specifications and/or CD will not be mailed until payment for materials and postage has been received. A copy of the Bidder Package is also on file at the City Clerk's office in City Hall at 300 Forest Avenue and the Central Coast Builders Association (831) 758-1624.
