

ORDINANCE NO. 19-013

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE AMENDING PACIFIC GROVE MUNICIPAL CODE CHAPTER 3.42 GOLF LINKS ADVISORY COMMISSION

FINDINGS

1. The City of Pacific Grove's Golf Links Advisory Commission (GLAC) is composed of seven voting members appointed by the Mayor and approved by the Council as follows: one member from each of the three golf clubs at the Pacific Grove Municipal Golf Course (golf club, senior men's club, women's golf club), recommended by each club to the Mayor; three at-large members who are Pacific Grover residents not affiliated with any of the three Pacific Grove golf clubs; and one business owner or manager from a member of the Pacific Grove Chamber of Commerce or the Hospitality Improvement District who is not affiliated with any of the three Pacific Grove golf clubs. If, for any reason, a person in one of the above categories is not available to serve, the Mayor may appoint a person who meets the general qualifications as stated in PGMC 3.42.020.
2. The GLAC should represent the interests and knowledge of Golf Course users, including those who are club members whether or not they are residents.
3. Council Policy 000-5 currently provides that members appointed to represent the golf clubs need not be residents.
4. The GLAC at their July 31, 2019 meeting recommended to change the residency requirements, such that residency is not required for the Golf Club representatives.
5. This Ordinance amends sections of PGMC Chapter 3.42.020
6. This Ordinance does not constitute a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15378.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE DOES ORDAIN AS FOLLOWS:

SECTION 1. The above findings are true and correct and by this reference are incorporated as an integral part of this ordinance.

SECTION 2. Sections 3.42.20 of the Pacific Grove Municipal Code shall be amended by replacing the existing sections with the following:

3.42.020 Member qualifications.

The members of the commission shall be residents of the city of Pacific Grove (except the three golf club members and the chamber/hospitality representative, who need not be a-Pacific Grove residents) and shall have an interest in the game of golf and/or the Pacific Grove Municipal Golf Course.

SECTION 3. The City Council declares that, should any provision, section, paragraph, sentence, or word of this ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences, or words of this ordinance as hereby adopted shall remain in full force and effect.

SECTION 4. This ordinance takes effect 30 days following the date of its passage.


