

**RESOLUTION NO. 15-062**

**AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH ANDERSON PACIFIC ENGINEERING CONSTRUCTION INC. FOR THE STORM DRAIN AND SANITARY SEWER IMPROVEMENTS ON 14TH STREET, SINEX AVENUE AND JUNIPERO AVENUE, INCLUDING GREENWOOD PARK CDS UNIT**

1. The City of Pacific Grove ("City") is responsible for structural maintenance of publicly owned infrastructure and upgrades for safety. The Pacific Grove Municipal Code Chapter 2.16.320 requires projects involving an expenditure of more than \$35,000, are approved by City Council by resolution.
2. Neill Engineers Corp., the City's engineer, completed all the engineered drawings and job specification for the 2015 Storm Drain and Sanitary Sewer Improvements on 14th Street, Sinex Avenue and Junipero Avenue, including Greenwood Park CDS unit. The City received two sealed bids for the project with the lowest responsible bidder being Anderson Pacific Engineering Construction Inc. in an amount not to exceed \$1,323,752 plus a 15% contingency
3. The Proposition 84 Grant, ASBS Fund 79, a reimbursable grant, will fund all of the storm water improvements totaling \$723,657. The sewer portion of the projects has been allocated in the City's sewer fund at a cost of \$600,095, Fund 76.
4. This action is categorically exempt as defined under the California Environmental Quality Act (CEQA) under Class 2, Article 19, Section 15302(c), Replacement or Reconstruction.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE:**

1. The foregoing Findings, as set forth above, are by this reference incorporated as an integral part of this Resolution.
2. The City Manager is authorized to execute all documents and to perform all other necessary City acts to enter into an agreement with Anderson Pacific Engineering Construction Inc. for the 2015 Storm Drain and Sanitary Sewer Improvements on 14th Street, Sinex Avenue and Junipero Avenue, including Greenwood Park CDS unit in an amount not to exceed \$1,323,752 plus a 15% contingency
3. This Resolution shall become effective immediately following passage and adoption hereof.
