

RESOLUTION NO. 20-015

RESOLUTION OF THE CITY COUNCIL OF PACIFIC GROVE DESIGNATING THE PACIFIC GROVE COASTAL BICYCLE AND PEDESTRIAN TRAIL

FINDINGS

1. Bicycling and walking along the Pacific Grove coast is popular for visitors and residents.
2. The trail has an unhindered view of the water and provides many benefits to residents and visitors alike.
3. Well maintained and clearly designated bicycle routes and pedestrian walkways help ensure public access while protecting coastal resources.
4. City efforts are ongoing to complete an improved continuous pedestrian trail along the coast, i.e. The Point Pinos Trail.
5. In 2018 the Transportation Agency for Monterey County (TAMC) adopted the county-wide Active Transportation Plan for Monterey County, which includes the pedestrian and bicycle trails proposed for designation.
6. This trail is the preferred trail location within the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE:

1. The Council determines that each of the Findings set forth above is true and correct, and by this reference incorporates those Findings as an integral part of this Resolution.
2. The Council authorizes designation of The Pacific Grove Coastal Bicycle and Pedestrian Trail.
3. The City shall take all appropriate actions to preserve and enhance The Pacific Grove Coastal Bicycle and Pedestrian Trail.
4. The Pacific Grove Coastal Bicycle and Pedestrian Trail is the preferred location for a coastal trail and shall be so acknowledged in any future development along its path.
5. The Pacific Grove Coastal Bicycle and Pedestrian Trail shall be so designated in all future informational and planning documents where bicycle and pedestrian trails are indicated.

6. This Resolution shall become effective immediately following passage and adoption thereof.
