

## **RESOLUTION NO. 17-029**

### **RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFIC GROVE AND CLASSIC CALPERS NON-REPRESENTED EMPLOYEE MEMBERS TO AMEND THE CALPERS RETIREMENT CONTACT FOR COST SHARING UNDER GOVERNMENT CODE SECTION 20516**

#### **FINDINGS**

1. The City of Pacific Grove and the Classic Miscellaneous and Safety non-represented employee members have agreed to amend the CalPERS retirement contract under Government Code Section 20516, employee cost sharing.
2. The City of Pacific Grove and the Classic Safety non-represented employee members have agreed to share 5% of the employer's rate for an employee total contribution of 14%.
3. The City of Pacific Grove and the Classic Miscellaneous non-represented employee members have agreed to share 5% of the employer's rate for an employee total contribution of 12%.
4. The Classic Miscellaneous and Safety non-represented employee members desire to have their 5% cost share credited to the member's account under Government Code Section 20516.
5. Since no MOU exists for these employees, a resolution with the employees' signature must be submitted to CalPERS to begin the contract amendment process.
6. The Classic and Safety non-represented employees signatures in the attached certified copy provide agreement to amend the CalPERS contract under Government Code 20516.
7. This action does not constitute a "project" as defined by California Environmental Quality Act (CEQA) because it is an organizational or administrative activity that will not result in direct or indirect physical changes in the environment.

#### **RESOLUTION**

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF PACIFIC GROVE DOES RESOLVE AS FOLLOWS:**

SECTION 1. The City Council finds each recital set forth above to be true and correct, and by this reference incorporates each as an integral part of this Resolution.

SECTION 2. The City Council approves the CalPERS contract amendment request for Classic miscellaneous and safety non-represented employee members.

SECTION 3. The City Manager is authorized to execute all documents and to perform all other necessary City acts to implement the CalPERS contract amendment request under Government Code Section 20516.

SECTION 4. This resolution confers authority upon the City Manager to take all steps necessary to implement CalPERS contract amendment request under Government Code Section 20516 and authorizes budget adjustments if necessary to implement expenditures during FY 17/18 and FY 18/19.

SECTION 5. This Resolution shall take effect immediately following its adoption.


